Heal the Heroes is a 1 year program that starts by focusing on healing, retraining and repurposing these heroes into what we call H.S.O.'s. These H.S.O.'s then deploy to natural and man-made disasters across the globe to help those most in need. They also deploy globally for Anti-Human Trafficking operations to work alongside local police, prosecutors, and special task forces to assist in shutting down these criminal operations and to rescue victims and children. Aerial Recovery also provides support to partner organizations who assist with the aftercare of victims and the prevention of at risk children through donations for aftercare, adoptions and more.
